The 25<sup>th</sup> meeting of State Level Executive Committee (SLEC) of HSHDA was convened on 09.10.2017 at 04:30 PM under the Chairmanship of Principal Secretary, Agriculture & Farmers Welfare Department-cum-Chairman, HSHDA in Haryana Niwas, Sector-3, Chandigarh. At the outset, the Chairman welcomed the members of the SLEC. Thereafter, Dr.B.S. Sehrawat, Mission Director, HSHDA apprised the House about the agenda. Agenda items were discussed and decisions taken during the meeting are as under:-

#### Agenda No. 3: Review of progress of MIDH for the year 2017-18.

Mission Director apprised the House that Govt. of India has approved Annual Action Plan for an amount of Rs. 109.29 crore (including Rs. 6.23 crore for committed liabilities) during 2017-18 under MIDH. The opening balance as on 01.04.2017 was Rs. 8.22 crore. The 1<sup>st</sup> instalment of Rs. 50.00 crore was released by Govt. Further, State Govt. has also released Rs. 6.95 crore as 15% Extra State Share for polyhouses. The total funds available under MIDH are Rs. 65.17 crores out of which 32.80 crore has been utilized. The balance funds as on 01.10.2017 available with HSHDA are Rs. 32.37 crore.

The Chairman reviewed the component-wise and district-wise achievements under Mission for Integrated Development of Horticulture (MIDH) upto September, 2017. He directed to expedite the utilization of balance funds i.e. 32.37 crore. It was observed that in district Mewat, Panchkula and Rohtak the financial achievement was less than 10% of financial targets as per AAP 2017-18. The Chairman instructed that concerned Member Secretary, DHMIUs may be made accountable for low achievements. Farmers Producer Organizations (FPOs) should be aware regarding horticulture schemes to cover more number of beneficiaries. The district level officers should participate in Monthly, Grievances, *Zila Parishad* and other meetings organized by district administration so that the maximum awareness of departmental schemes could be made. Further, he

emphasized that an advertisement should again be given in leading newspapers for the components in which achievements are low.

The Chairman desired to add a member from National Horticulture Board (NHB) and Haryana State Agriculture Marketing Board (HSABM) in existing Technical Monitoring Committee for monitoring of major project-based activities like cold stores, marketing infrastructure etc.

The Mission Director apprised the House that under MIDH a total of 6150 beneficiaries against a target of 20,000 has availed Direct Benefit Transfer (DBT) till September 2017. The Chairman appreciated the efforts made to release the assistance to the beneficiaries through DBT using HORTNET Payment Gateway Portal by HSHDA.
