During review of Action taken report the following decisions were taken:

- 3.1 Under Small Nursery (Private) component, targets has been given to Districts Sonipat & Hisar. MS, DHMIU Sonipat has achieved the target & made payment of 1st installment. MD instructed to make the remaining payment. MS, DHMIU Hisar has assured to achieve the target by next week.

(Action taken by: MS, DHMIU Sonipat & Hisar)

- 3.2 MD directed all MS, DHMIUs to demand the funds under components for which payments are to be made at district level. It was directed to utilize the funds only for those components for which demand has been made.

(Action taken by: All MS, DHMIUs)

- 3.3 MD instructed that the farmers who have already availed subsidy under Floriculture component shall not be repeated. MS, DHMIUs were also instructed not to exceed the targets given under Hybrid vegetable component.

(Action taken by: All MS, DHMIUs)

- 3.4 Garlic seeds are being procured by HSDC. MS, DHMIU Bhiwani, Yamunanagar, Karnal & Panipat had demanded G-50 variety of garlic seed. Seeds shall be distributed on 'First Come First Serve' basis.

(Action taken by: All MS, DHMIUs, HC-I)

- 3.5 Under Mushroom Projects component, achievements are not satisfactory. MD, instructed MS, DHMIUs to send the cases to HQ by next week or to surrender the targets so that it can be transferred to some other district as per the requirement.

(Action taken by: All MS, DHMIUs, HC-II)

- 3.6 Priority list under creation of water resources shall be prepared. MS, DHMIU Hisar & Sirsa were directed to prepare agenda for excess applications beyond targets & to discuss with ADC so that the cases may be considered for construction in convergence with MGNREGA.

(Action taken by: MS, DHMIUs Hisar & Sirsa)

- 3.7 Under Protected Structure component, State Govt. is going to release 15% extra state share shortly. Therefore, MD instructed all MS, DHMIUs to send

report of accurate beneficiary list of 2015-16 & 2016-17 to HQ. MD also directed all MS, DHMIUs that the inspection of completed structures may not be delayed and if any company has not completed the structure within the stipulated time period, the same may be reported so that the said company not be considered for further work.

(Action taken by: All MS, DHMIUs, PSE-I)

3.8 All MS, DHMIUs were directed to achieve the targets under Vending Cart at earliest or surrender the same so that the targets can be transferred to some other district as per requirement.

(Action taken by: All MS, DHMIUs)

Agenda No. 4: Review of progress of SCSP component under MIDH scheme up to August, 2016.

Report under SCSP has been received from few districts. MD instructed all MS, DHMIUs to submit the report within 2 days.

MD directed all MS, DHMIU that if SC farmers are not available under protected structure component then the achievement in general category may be reduced simultaneously so as to make it proportionally at par.

(Action by: All MS, DHMIUs)

Agenda No. 5: Beneficiaries' data on DBT.

The format of the report was not correct. Hence, the report may be discarded.

(Action by: All MS, DHMIUs)

Agenda No. 6: Brief Power-point Presentation on protected structure by DHCs.

DHC Yamunanagar, Kurukshetra & Gurgaon had given brief presentation on protected structures.

(Action by: All MS, DHMIUs, DHCs & PSE-II)

Agenda No. 7: Review of Progress of Centre of Excellence.

MD instructed to expedite the work at all Centre which are under progress. MS, DHMIU Narnaul was directed to release the funds in instalments to the CA, Marketing Board. MD also instructed to work as per the DPR. Leveling of land and creation of water resources is to be taken up at the earliest.

MS, DHMIU Palwal was also instructed to work as per DPR. MS, DHMIU Palwal & Narnaul were instructed to prepare the execution plan of work to be done at their Centres & sent to HQ.

(Action by: In-charge CSTF, In-charge IBDC, MS, DHMIU Palwal, Narnaul & Jhajjar)

Agenda No. 8: Any other item with the permission of Chair.

- 8.1 Funds were transferred to HAIC, Murthal, MD instructed EO, SO & MS, DHMIU Sonipat to tie-up with HAIC to monitor & report within 15 days.
- 8.2 DBT data should be uploaded to HORTNET as per GOI instructions already circulated.
