During review of Action taken report the following decisions were taken:

3.1. All MS, DHMIUs were directed to strictly follow NCOF guidelines for organic farming. The clusters for organic farming can be integrated with other horticultural activities.

3.2 All MS, DHMIUs were instructed to achieve 80% target under area expansion till 10th August, 2016. It was also instructed to strictly follow the district Annual Action Plan so that no extra targets are achieved.

(Action taken by: All MS, DHMIUs)

3.3 It was discussed in the house; total 100% targets under Bee-Keeping component shall be allotted to SCSP category. Farmers will submit application form with DD amount of 10% assistance in concerned office. The assistance should be released on 'First Come First Serve' basis subject to the beneficiaries should not be repeated.

3.4 Under INM component the assistance should be released to beneficiaries purchasing inputs from IFFCO, KRIBHCO, NFL etc accordingly.

Few districts have not submitted the progress under SCSP component. So, MD instructed all MS, DHMIUs to submit the report within 2 days.

It was also instructed to send the monthly progress report to HQ by 2nd & 3rd of every month in prescribed performa.

Agenda No. 8: Review of Progress of 'Baag Lagao Abhiyan-2016'.

'Baag Lagao Abhiyan-2016' is being organised in all MIDH districts to promote the new plantation of fruit crops. Most of the districts have organised this event. However, the program organised by MS, DHMIU Rohtak was not satisfactory. MD instructed to organise this event in remaining districts with participation of progressive farmers on large scale, so that maximum area can be taken up under horticulture crops. A brief report about the program along with coverage report & photographs will be submitted at HQ.

Agenda No. 9: Additional assistance of 15% as State Share for protected structure during 2015-16 & 2016-17.
