MINUTES OF 29th MIDH MEETING HELD ON DATED 09.09.2017 AT 10:30 AM AT HTI, UCHANI, KARNALUNDER THE CHAIRMANSHIP OF DR.B.S. SEHRAWAT, MISSION DIRECTOR, HSHDA, HARYANA, PANCHKULA.

The meeting was started by welcoming all the members and the agenda was discussed and actions taken are as under:-

Agenda No. 1: Confirmation of the proceedings of 28th MIDH meeting.

The minutes of 28th MIDH meeting which was held on dated 19.08.2017 were circulated vide memo no.2953-2986/Hort-APO/NHM/5/XI/III dated 28.08.2017.As no comments were received from any quarter, so the minutes of 28th meeting were confirmed.

Agenda No. 3: Component-wise review of progress made under MIDH scheme for the month of August, 2017.

The component-wise physical & Financial expenditure was reviewed by Mission Director. Following decisions were taken during review of components:

3.1 Under the component of Maintenance (Ist & IInd year), Area expansion &, IPM/INM, Plastic crates, Vending carts, Onion storage structure & Mechanization, the achievements was found low in some districts. MD took the matter seriously & instructed MS, DHMIUs to explain their position for low achievement under above said components as well as to issue show cause notice to concerned District Horticulture Consultants. However, such DHCs were directed to achieve the significant target before 30.09.2017 failing which their services can be discontinued in future.

In the meeting, it was observed that the figures under the component of 1st and 2nd year maintenance (Normal and High Density crop) were found mis-matched in Annual Action Plan for the year 2017-18 with the actual area planted in 2015-16 and 2016-17. In this regard, it was decided that concerned DHCs to visit HQ on 12.09.2017 for correction in their targets.

(Action taken by: All MS, DHMIUs)

3.2 Under the component of Hybrid Vegetables (Tomato), as instructed earlier MS, DHMIUs have to expedite the issuance of permits to farmers for purchase of seed from HSDC counter and submission of subsidy claims on online portal in a time bound manner to avoid any kind of litigation. The instructions issued in this regard should be followed strictly.

(Action taken by: All MS, DHMIUs)

3.3 Under the component of spices (Garlic), on the request of MS, DHMIUs, it was clarified that the farmers who are availing the assistance for cultivation of Hybrid Vegetable (Tomato) are also eligible for procurement of Garlic seed.

(Action taken by: HC-I & All MS, DHMIUs)

3.4 MS, DHMIU, Mewat has requested for excess targets under component of rejuvenation/replacement of senile plantation. It was decided that 5 ha. area under this component may be transferred from Ambala to Mewat.

(Action taken by: HC-I, JC (IT) & Concerned MS, DHMIUs)

Agenda No. 4: Status of additional assistance of 15% as State Share for protected structures during 2017-18.

The report of district Panchkula and Palwal is still awaited regarding additional assistance of 15 percent. MD, instructed to submit the same within a week.

(Action taken by: PSE-I & Concerned MS, DHMIUs)

Agenda No. 5: Review of progress of SCSP component under MIDH Scheme up to August, 2017.

The report of district Panchkula and Palwal is still awaited regarding SCSP component. MD, instructed to submit the same within a week.

(Action taken by: SAO, HC-II & All MS, DHMIUs)

Agenda No.-6: Targets & achievements of DBT under MIDH.

Physical achievements of district Fatehabad, Jhajjar, Kurukshetra, Panchkula, Rohtak and Sonipat was observed less than 20 percent under subsidy disbursed through DBT. MD took the issue of low physical achievement very seriously and instructed all districts to achieve at least 50% physical achievement as per instructions issued till 30.09.2017.

Agenda No.7: Review of progress of Centre of Excellence.

The inauguration of Integrated Bee-Keeping Development Centre, Ramnagar, Kurukshetra is likely to be held in October, 2017. MD, instructed DDH/IBDC to make arrangements for the same and expedite the work which are

pending. MS, DHMIU Narnaul informed that the work of construction of boundary wall and land levelling is under progress at Centre of Excellence of Horticulture at Sunderah, Narnaul. HC-III informed house that the construction of Hi-tech Green house at Hodal Palwal will be started very soon and the location has to be earmarked. MD, instructed concerned Centre In-charges to expedite the work of development at all Centre of Excellence in Haryana State.

(Action taken by: Concerned Centre In-charge)

Agenda No. 8: Any other item with the permission of Chair.

8.1 Presentation by DHCs: The District Horticulture Consultants of district Hisar, Sirsa, Fatehabad, Bhiwani, Narnaul, Jind and Mewat gave their presentation regarding Status of Poly Houses in their districts. The information as presented, in some districts was not as per performa circulated earlier. MD, instructed to follow the instructions issued by HQ from time to time and provide desired information accurately. The presentation of remaining DHCs will be presented in next meeting. It was also decided in the meeting that a complete list of beneficiaries of Protected Structures be prepared in prescribed performa (already updated in meeting) & submitted to HQ within 15 days.

During the presentation, it was observed that some protected structures were in non-working condition due to lack of interest of beneficiary & some structures were also found in damaged condition or were up-rooted due to natural calamity or other reasons. In this regard, all the MS, DHMIUs were directed to take appropriate action to run the structures successfully in order to avoid misuse of Govt. funds. Failing which notice should be issued to the concern & inform to Mission Director, so that the matter could be taken up with Govt.

The meeting ended with a vote of thanks to the Chair.
