Agenda No. 3: Component-wise review of progress made under MIDH scheme for the month of January, 2018.

The District-wise & component-wise Physical & Financial expenditure was reviewed by Mission Director. The following decisions were taken during review of components:

3.1. It was observed that under the component of Hybrid Vegetable Cultivation (Tomato), the physical achievement was around 2000 ha against a target of 4000 ha. During discussion, MS, DHMIU, Hisar, Jind and other districts informed that the tomato hybrid seed of the empanelled firms is not available on HSDC sales counter. Some farmers of district Hisar have also reported that the HSDC sales counter remains closed and seed of desired variety of empanelled firm is not available there.

It was decided by the House that keeping in view the optimum sowing time of summer tomato crop (i.e. February) the farmers may be allowed to purchase seeds of their desired variety from the empanelled firms at their own level as per the rates decided by HSDC. In such case, the service charge as decided by HSDC will not be applicable.

Further, if farmers are unable to purchase seeds at their own level then in order to facilitate the farmers, concerned MS, DHMIUs may procure the seed for their district as per farmers' demand, choice of variety and distribute to the interested farmers. The difference of the eligible subsidy and the cost of seed should be transferred to the farmers account through DBT using HORTNET portal.
