Agenda No. 3: Progress of MIDH for the year 2017-18.

DDH/N apprised the House that Govt. of India had approved Annual Action Plan for an amount of Rs. 139.29 crore (including Rs. 6.23 crore for committed liabilities) during 2017-18 under MIDH. During the year, the funds an amounting of Rs. 126.29 crore were available, out of which Rs. 111.26 crore were utilized which is 88 percent. The balance funds an amount of Rs. 15.03 crore will be utilized after revalidation from Govt. of India. The committed liabilities as on 31.03.2018 were for an amount of Rs. 25.54 crore and the provision for the same has been made in Annual Action Plan for 2018-19. All the MS, DHMIUs were directed to upload the cases of committed liabilities related to their respective district on HORTNET portal, accordingly.

MD appreciated the physical & financial achievements of District Yamunanagar, Palwal, Sirsa where Member Secretaries of these districts have performed well for the year 2017-18.

A total of 21,065 physical numbers of beneficiaries has been covered under DBT against a target of 20,000 numbers.

The funds an amount of Rs. 695.00 lakhs were released as additional assistance of 15% as State Share for protected structures during 2017-18 and same has been utilized accordingly.
